2. An average of 23 lines per page, 3 pages ABSOLUTE MINIMUM)  $\frac{3}{4}$  inch (rather than 1 inch) margins are required unless you go beyond the 3 pages to compensate for your wider margins and fewer lines per page.
- \* 3. Put title of the paper, your name and course identifiers on a separate page. It does not count as 1 of your 3 pages. \* The WRITING CENTER is a good option for correcting grammar/sentence construction problems.
4. Do NOT include a paragraph at the end which merely summarizes what you already stated in your paper.
5. Your mandatory alphabetized bibliography does not count as 1 of your 3 pages.
6. Double spacing throughout (if there is any triple spacing between paragraphs, you will need to continue your discussion on a 4<sup>th</sup> page to compensate for this triple spacing.)
7. Avoid presenting case histories (e.g., I want to tell you about my Aunt Millie who was diagnosed with Alcohol Dependence ---) Presentation needs to discuss general trends backed up with research studies cited by you. \* To separate 1 paragraph from another, indent 3 spaces when starting a new paragraph.
- \* 8. Remember—an absolute minimum of 5 RESEARCH STUDIES, ALL FROM PEER-REVIEWED JOURNALS, IS REQUIRED. If you have any doubts that it is a peer-reviewed journal, google it in terms of asking the question "Is (for example) the Journal of Abnormal Psychology a peer-reviewed journal?" You may need to cite 10 or 15 peer-reviewed journal references to document the statements that you make in your presentation adequately.
